TERMS AND CONDITIONS FOR

REV-UP-TO-WIN-REPCO-BATHURST-1000-RACE-WEEKEND_RIDES-PASSES-AND MERCH-PACKS -AT-BATHURST -CENTRAL-COMPETITION

- 1. Participation in this Promotion and information regarding redemption of any prize forms part of these terms and conditions. Participation In this REV-UP-TO-WIN-REPCO-BATHURST-1000-RACE-WEEKEND_RIDES-PASSES-AND MERCH-PACKS -AT- BATHURST -CENTRAL-COMPETITION ("Promotion") is deemed acceptance of these Terms and Conditions.
